Who is eligible to apply?

Any organization that provides consulting services to clients in Hong Kong or China and has at least one Certified Member (CMC) or Certified Fellow (FCMC) in a senior position or agrees to nominate at least one of their staff in a senior position to become a Certified Member (CMC) within one year, is eligible for IMCHK Corporate Membership.

IMCHK Corporate Membership Scheme

(Be part of consulting service development program for Greater Bay Area)

Corporate Membership is a program designed by IMCHK to expand and promote management consultancy to businesses, industries, and professional development in the Greater Bay Area. The Corporate Membership will support the development program of individual members to enhance professional consulting services in the area.

The scheme of membership includes:

Corporate Membership Fee

The one-time registration fee is HK\$1,500.

The annual subscription fee is based on the number of staff members of the relevant organization.

Annual subscription for consulting firms with 5 or more staff: HK\$12,000.

Annual subscription for consulting firms (SMEs) with 4 or less staff: HK\$9,000.

Terms of individual staff members under the Corporate Membership Scheme

- (1) Eligible for selection to the committee of IMCHK Council
- (2) Ability to join workgroups or sub-committees, such as the Greater Bay Area development workgroup) of the IMCHK council
- (3) Invited to industry meetings.
